<u>Recommendation #1 – Members who Became Eligible in 2010/2011 Fiscal Year</u> Staff recommends that the Operations Committee recommend to the Board of Retirement that the Board approve the inclusion of Certification Incentive Pay in compensation earnable for legacy members in the job classification groups which include Park Maintenance, Specialist, and Foreman since this incentive pay item is only provided to those who became eligible in the 2010/2011 fiscal year.

Recommendation #2 – Members with Entry Dates Before, On and After January 1, 2013

Staff recommends that the Operations Committee recommend to the Board of Retirement that the Board approve the inclusion of Certification Incentive Pay in compensation earnable and pensionable compensation for the job classification group of Open Space Maintenance Technician for members with entry dates before, and on or after January 1, 2013 (legacy and PEPRA members).

Recommendation #3 – Members with Entry Dates Before, On and After January 1, 2013

Staff recommends that the Operations Committee recommend to the Board of Retirement that the Board approve the inclusion of Higher Duty Pay for the employees temporarily assigned to special higher level assignments for members with entry dates before, and on or after January 1, 2013 (legacy and PEPRA members).
