1. Motion to Adopt Medicare Part B Reimbursement Amount for 2010 Recommendation and possible motion to continue to provide Medicare Part B Reimbursement to current eligible retirees at the monthly premium rate of \$96.40 during the 2010 calendar year.

Recommendation

Staff recommends continuing to provide the Medicare Part B Reimbursement Benefit (MBRP) to eligible retirees at the monthly premium rate of \$96.40 during 2010. This is the lowest Medicare Part B premium charged to enrollees for 2010. The MBRP benefit is a non-vested benefit funded by contributions from ACERA Employers to the 401(h) account. After contributions are made, in accordance with the CERL, ACERA treats an equal amount of Supplemental Retiree Benefits Reserve (SRBR) assets as employer contributions for pensions.

2. Adoption of Updates to Appendix A of 401(h) Account Resolutions Recommendation and possible motion to adopt revisions to 401(h) Account Resolution 07-29, Appendix A, amended to reflect Plan Year 2010 benefit amounts.

Recommendation

Staff recommends that Appendix A to Resolution No. 07-29 be revised and updated to reflect the changes approved by the Board to the Monthly Medical Allowance (MMA) and Retiree Health Benefit premiums for plan year 2010.
