

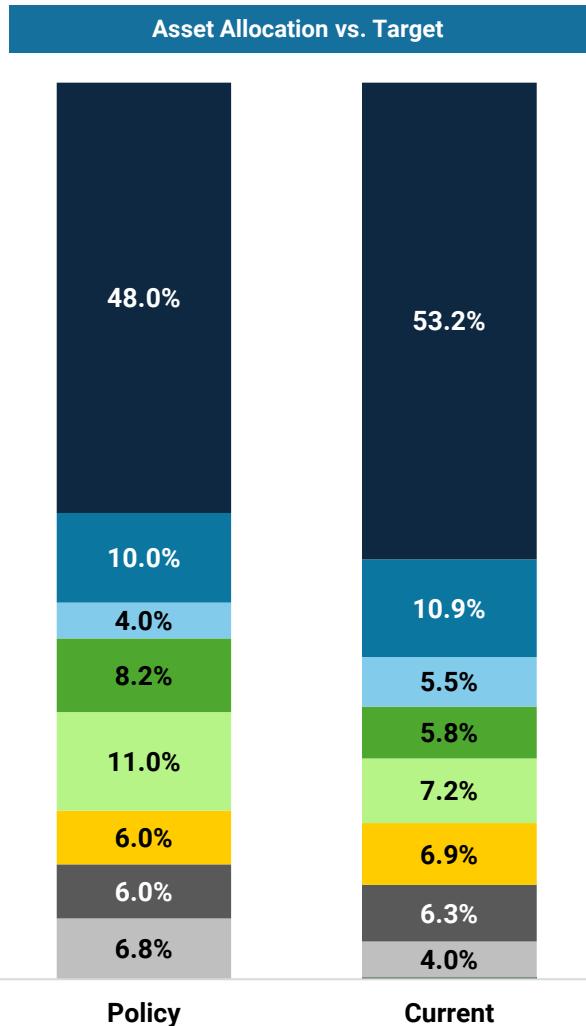

Market Commentary

Global equity markets overall ended 2025 on a strong note, supported by solid earnings growth, easing inflationary pressures, and expectations of lower interest rates in the new year. For the first time in several years, non-U.S. equities outperformed U.S. equities for the year, aided by several factors including a weaker U.S. dollar, attractive valuations outside the U.S., and the rotation away from U.S. technology stocks amongst some investors. U.S. stocks, represented by the Standard & Poor's 500, had a muted return of 0.1% for the month of December, and returned 17.9% for the full year. Non-U.S. developed markets, represented by the MSCI EAFE Index, returned 3.0% for the month and 31.2% for the year. Emerging equity markets, represented by the MSCI EM Index, similarly returned 3.0% for the month, and outperformed developed markets for the full year, returning 33.6%.

In fixed income, markets faced headwinds despite the Fed's rate cut of 0.25% in December. The yield curve steepened as yields rose in longer maturities, with the 10-year Treasury climbing to 4.18%. Core bonds, represented by the Bloomberg US Aggregate Index, posted a return of -0.1% for the month. Credit markets remained resilient, with high yield bonds delivering a return of 0.6%, represented by the Bloomberg US Corporate High Yield Index.

Portfolio Commentary

ACERA's Total Fund returned 0.73% for the month on a gross-of-fee basis, underperforming the Policy Index (Gross) by 31 bps. Public Equity outperformed its benchmark by 16 bps. Total Fixed Income underperformed its benchmark by 6 bps.

The Total Fund had an investment gain of \$102.0 million, ending the month with a market value of \$14.0 billion.

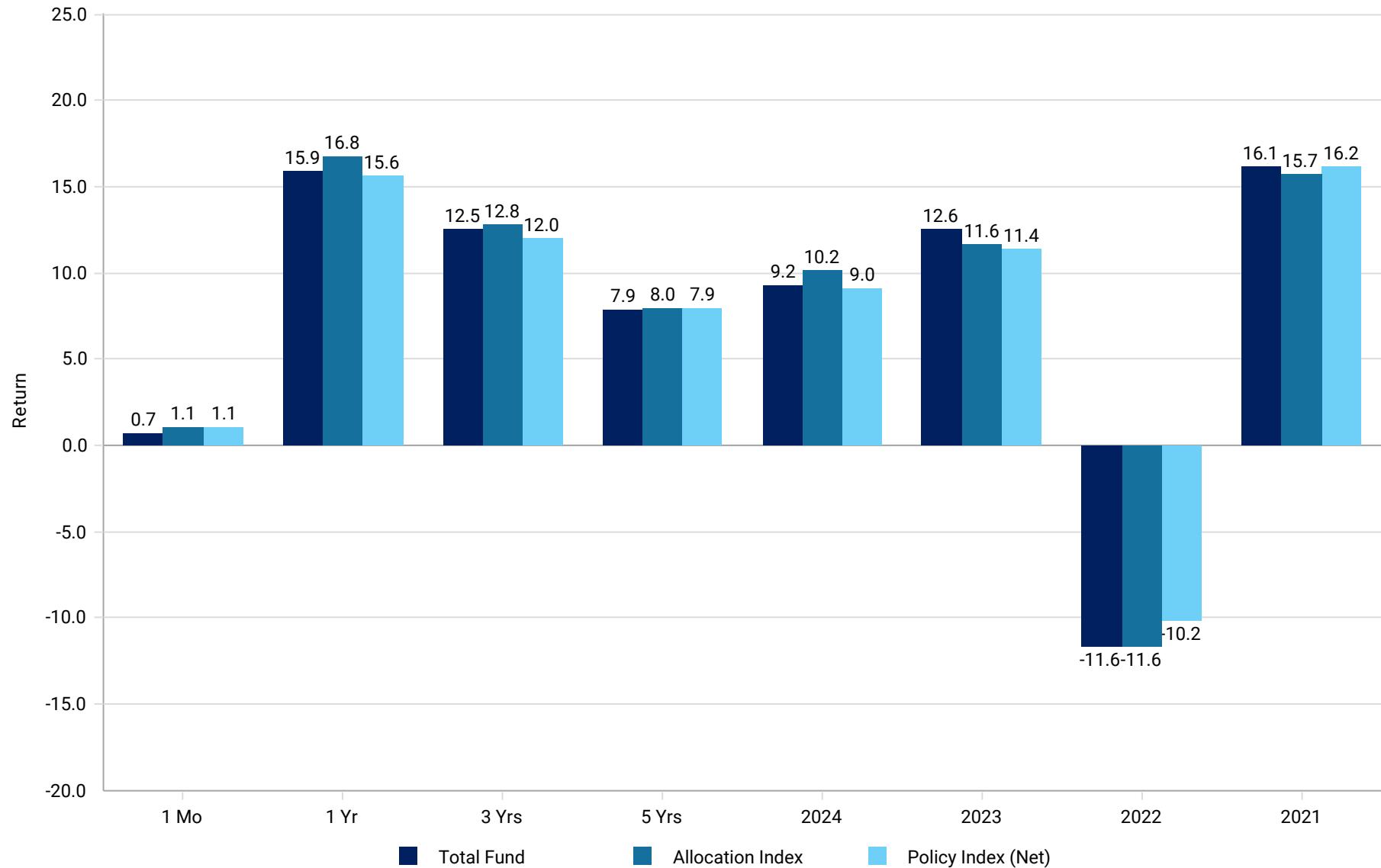
