ACERA will be conducting an election to fill three elected positions on the Board of Retirement. In November, active and deferred safety members and retired members will receive a ballot in the mail to vote for their representatives on the Board of Retirement. These statements are in addition to the material contained in the official ballot and may provide supplementary and different information. Please review this material carefully.

In the safety member election, the candidate with the most votes will be elected 7th Member Representing Safety Members, and the candidate with the second most votes will be elected Alternate 7th Member Representing Safety Members. In the retired member election, the candidate with the most votes will be elected 8th Member Representing Retired Members.

However, during the same period, ACERA weathered some serious challenges, notably the 2008-2009 GFC. Nevertheless, with the guidance of the ACERA investment staff and consultants, we emerged from the crisis largely intact. In addition to solid investment returns, ACERA made some important advancements including the hiring of an internal auditor, modifying the pension gold system, prioritizing cybersecurity, and launching a new website.

I was employed as an attorney in the Public Defender's office for over 30 years and understand the legal responsibilities of an ACERA trustee. Throughout the years I served on the Board of Retirement, I remained faithful to my fiduciary duty; I made every decision with the utmost care and with undivided loyalty to the health and welfare of the fund.

If elected, I look forward to representing the very knowledgeable retiree members. I have always been impressed with the level of engagement the retirees have with ACERA. I am very aware that the health of the Supplemental Retirees Benefits Reserve (SRBR) is of the utmost importance to retirees along with the overall performance of the fund.

We need the SRBR to ensure Alameda County retirees maintain their standard of living. It should protect the retirees, especially the vulnerable elderly retirees, from any decline in their economic wellbeing. To that end, the two most important benefits provided by the SRBR are the Monthly Medical Allowance and the Supplemental COLA. If additional benefits are granted, we first need to be certain the SRBR will last for the benefit of all current and future Alameda County retirees and their beneficiaries.

If elected, I look forward to working diligently both with my fellow trustees to promote the continued success of ACERA, and with the retirees of Alameda County to ensure they continue to receive the excellent service they deserve.

It has been an honor being elected to six consecutive terms to represent Safety members as the Alternate Safety Trustee on the Alameda County Employees Retirement Association Board (ACERA). Now that I am a retiree, I am eager to bring my experience and staunch advocacy to the representation of retired employees.

The annual Cost of Living Adjustment (COLA), healthcare for our retirees through the Monthly Medical Allowance (MMA), and the strength of the fund are

of utmost importance to me as a trustee. Previously, ACERA invested primarily in stocks and bonds with minimal exposure to real estate. We now target more than 15% of our assets toward Private Equity and Alternative investments, resulting in higher returns. During my tenure, our fund has grown to \$11 billion and we have increased the value of the Supplemental Retiree Benefit Reserve (SRBR) to over \$1 billion. We have also created a successful emerging managers program to include high performing women and minorities in our pool of fund managers.

During my 18 years as a trustee, I have served on the Investment, Operations, Governance, Actuarial, Audit and Retiree committees. I have completed certificate programs in Institutional Investing and Pension Fund Management at Harvard University, University of California Berkeley, University of Pennsylvania (Wharton School Of Business), and Stanford University. These institutional and educational experiences have empowered me to be an effective and impactful trustee. In 2008, I was elected to the Board of Directors of the State Association of California Retirement Systems (SACRS), where I have served as Secretary and Vice-President. My involvement in county retirement systems on the state level has enhanced my understanding of the issues surrounding public pension funds and enabled me to keep my colleagues from Alameda County better informed on state and national issues, including legislative developments. I have earned the respect of trustees statewide who have twice elected me to the executive board, and as a result was able to give Alameda County representation at the state level. I am currently on the Advisory Council for the National Association of Securities Professionals (NASP), as well as a USAID delegate, where I represent the US State Department in seeking investment opportunities in Africa.

As an elected ACERA Trustee, I made it a priority to always be accessible, and have enjoyed participating in ACRE and REAC luncheons and events. I appreciate the support I have received and look forward to serving as the Retiree Trustee. I am asking members to support my candidacy to be the retiree representative by voting for me in the upcoming election, and to feel free to contact me if they have any questions or concerns regarding ACERA.
