





- 1. From March 19, 2018 to April 9, 2018, ACERA engaged in a transition process to rebalance five US equity portfolios into BlackRock's Russell 1000 index fund.

 Since the assets were transferred into the BlackRock account mid-month, the full monthly return was not available.

 2. The Total Fund is calculated using the latest available valuations for Private Equity, Absolute Return, Real Estate and Real Assets.

 3. The Policy Benchmark reflects the 2/28/18 NCREIF ODCE and the latest available Core CPI.

 4. The Real Assets Custom Benchmark was adopted by the Board in March 2016 and consists of 35% S&P Global Infrastructure Index/50% S&P Global Natural Resources Index/ 15% Bloomberg Commodity Index.*

 5. The Beginning Market Value differs from the March Ending Market Value as a result of an approximately \$380,000 (downward) adjustment in the Artemis account (HIBQ).
