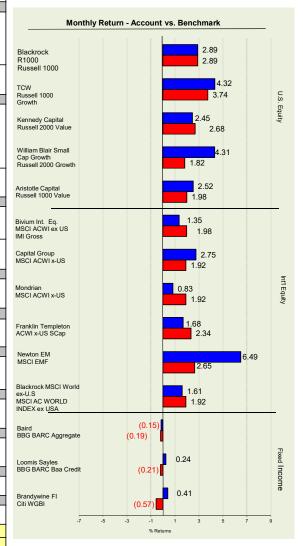

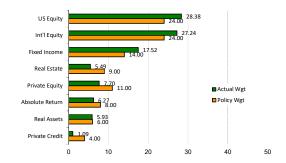
Monthly Summary

ACERA's Total Fund returned 1.45% in August underperforming the policy index by 54 bps. The Int'l Equity asset class outperformed its benchmark by 20 bps and the U.S. Equity asset class outperformed its benchmark by 14 bps. The Fixed Income asset class outperformed its benchmark by 21 bps. Newton Emerging Market Equity outperformed its benchmark by 384 bps and Mondrian underperformed its benchmark by 109 bps. The ending market value of the Total Fund was \$11,591,812,084.
