# **Deputy District Attorney**

My name is Scott Ford, and I am running for election to the Board of the Alameda County Employees Retirement Association (ACERA). I believe my experience and serving the people of Alameda County, coupled with my knowledge of economics, will make me an asset to the ACERA Board and to all the members it represents.

ACERA is the organization that manages retirement benefits for employees and the Board of trustees is responsible for safeguarding those benefits through the careful investment of retirement contributions. The contributions you make, and their investment proceeds fund your pension. A portion of investment returns also fund a reserve account for non-vested benefits, including a medical allowance that helps offset the lifetime cost of

healthcare in retirement, as well as a supplemental COLA to ensure that your purchasing power in retirement never falls below 85% from the date that you retire. As a Board member, I would work diligently with the other trustees to protect and ensure the current standard of retirement benefits.

My background meets the unique qualifications and standards required of a Board trustee. I have a BA in Economics, cum laude, from the University of San Diego and a JD from the University of San Francisco. For over 16 years I have served as a Deputy District Attorney for Alameda County. Having spent my career representing the public at large, I am keenly aware of the fiduciary obligations inherent as a Board trustee and will always act in the sole interest of the ACERA Trust, the members, and their beneficiaries.

The ACERA Pension Fund, while not fully funded, is financially strong at over 91% funding and is expected to be fully funded soon. If elected, I will continue that drive toward full funding and have the endorsement of the Investment Chair, George Wood, as well as other endorsements listed below.

It is my desire to work on your behalf to ensure that you have a retirement free from financial worry and am asking that you vote for me as your trustee representative for ACERA's Board of Retirement.
