Subject: Summary of the May 16, 2012 Operations Committee Meeting

ACTION ITEM

1. Discussion and possible motion regarding a member's appeal of ACERA's decision to deny a request for the Unmodified Option Continuance benefit

Robert Gaumer, Chief Counsel and Kathy Foster, Assistant CEO discussed the matter of Mr. Lincoln Edmond's request to receive Unmodified Option continuance benefits as the spouse of our late member Mary Edmond. Mr. Edmond was not designated as her beneficiary.

Ms. Liz Koppenhaver moved and Ms. Ophelia Basgal seconded that the Operations Committee recommend to the Board of Retirement that the Board affirm ACERA's decision to deny the request for Unmodified Option continuance benefits to spouse Lincoln Edmond who was not designated as a beneficiary of our late member Mary Edmond. The motion passed unanimously. Trustees George Wood and Darryl Walker recused themselves from the discussion and voting of this Action Item.

1. Quarterly Financial Statement as of March 31, 2012

Vince Brown, CEO presented the quarterly financial statements as of March 31, 2012. For the period ending March 31, 2012 net assets held in trust for pension benefits total \$5,527,475,816.

Vince Brown, CEO presented the year-to-date operating expenses – budget vs actual. As of March 31, 2012 actual expenses are under budget \$201,216.

4. Call Center Report
