#### 1. Supplemental Retiree Benefit Reserve (SRBR) Financial Status

Margo Allen, Fiscal Services Officer, presented a 10-year history of the Supplemental Retiree Benefit Reserve (SRBR) activity through December 31, 2012. Approximately \$6.8 million of interest was credited to the SRBR fund for the second half of 2012, using a semi-annual interest crediting rate of 1.1710%. The total interest credited to the SRBR for 2012 was approximately \$9.3 million. The December 31, 2012 ending balance was approximately \$570.9 million.

# 2. Status Update on Project Plan for Early Retiree Medical Coverage through Health Exchange

Kathy Foster, Assistant Chief Executive Officer, provided information on recent activities and an updated timeline related to the California Health Exchange project.

## 3. Miscellaneous Updates
