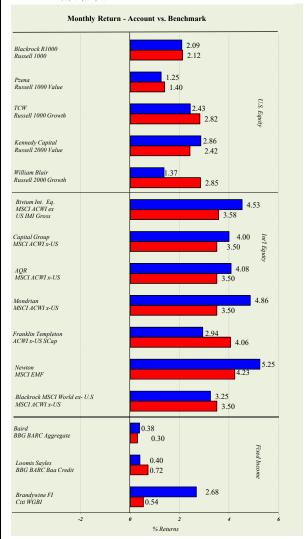

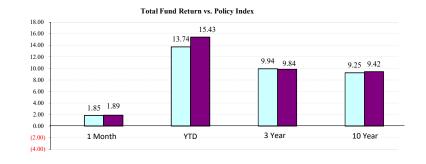

Monthly Summary

ACERA's Total Fund returned 1.85% in October underperforming the policy index by 3 bps. The Int'l Equity class outperformed its benchmark by 48 bps and U.S. Equity class outperformed its benchmark by 3 bps. The Fixed Income class outperformed its benchmark by 57 bps. Brandywine Global FI outperformed its benchmark by 214 bps and Franklin Templeton Inv.underperformed its benchmark by 112 bps. The ending market value of the Total Fund was \$8,461,674,205.

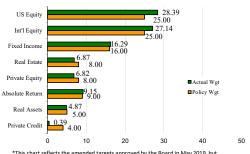


Asset Allocation - Actual vs. Target*
