Purchasing other public service credit increases your retirement benefit, but does NOT count towards retirement eligibility or vesting requirements. In addition, you **cannot** be eligible for a benefit from the other retirement agency, nor can the service overlap with your ACERA service. Verification of your employment with the other retirement agency is required. Therefore, you must forward this form to the other reciprocal agency for completion (please see the attachment for a list of addresses).
