

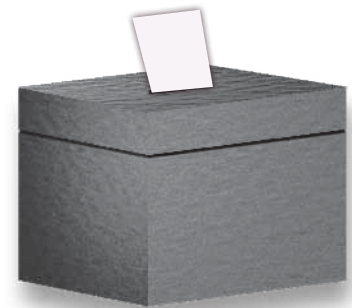


Retirement Board 2013 Election



A message from the Chief Executive Officer

ACERA will be conducting an election to fill three elected positions on the Board of Retirement. Active and Deferred ACERA members will receive a ballot in the mail in November to select a candidate for the following positions: General Members will select a candidate for **Third Member to Represent the General Members**; Safety Members will select a candidate for **Seventh Member to Represent the Safety Members**; and the candidate belonging to a statutory group not otherwise represented by the elected Seventh Member who receives the second most votes will be elected as the **Alternate Seventh Member to Represent the Safety Members**.



As an ACERA member, this is your opportunity to vote for the member of the Board who represents you. ACERA's Board meets monthly through the year, making decisions that affect your retirement system. Enclosed you will find a campaign statement from each of the candidates. These statements are in addition to the material contained in the official ballot and may provide supplementary and different information. Please review this material carefully. Return your ballot by 12/18/13.

I have been elected to three terms representing Juvenile Institutional Officers, Deputy Probation Officers, Probation Management, the Alameda County Sherriff’s Office, and Safety Members from the District Attorney’s office as the Inaugural Alternate Safety Trustee on the Alameda County Employees Retirement Association Board (ACERA).

When I receive calls from Safety members who have a question or concern about ACERA, I take pride in not only answering questions, but also in directing my constituents to the staff member who will best assist them. I have become known as a staunch advocate for the rights and benefits of safety members and retirees.

I understand the importance of our fund remaining strong. Prior to the stock market downturn in 2008, ACERA invested primarily in stocks and bonds with a little exposure to real estate. Since then we have targeted ten percent of our assets toward Private Equity and Alternative investments. I am happy to report that our fund has almost completely recovered. Our fund is currently in excess of \$6.2 billion. I am also very proud to say we have created a successful emerging managers program to include top quality women and minorities in our pool of fund managers.

During my tenure on the ACERA Board, I have sought out educational opportunities to enhance my knowledge. I have completed certificate programs in Institutional Investing and Pension Fund Management at Harvard University, University of California Berkeley, University of Pennsylvania (Wharton School Of Business), and Stanford University. These educational experiences have been critical in preparing me to carry out my responsibilities as a trustee.

I have also served as Vice President on the Executive Board of the State Association of County Retirement Systems (SACRS). SACRS is composed of twenty 1937 Act counties in California and represents over \$100 billion in pension fund assets. My involvement in county retirement systems on the state level has enhanced my understanding of the issues surrounding public pension funds and enables me to keep my colleagues from Alameda County better informed on statewide issues, including legislative and judicial developments. I am proud to have earned the respect of trustees statewide who have twice elected me to this position, and equally proud to be able to give Alameda County representation on the SACRS executive board.

A Healthy System

My name is George Wood and I am seeking your vote to be re-elected to the Board of ACERA

Briefly, ACERA is the organization that administers the retirement benefits for County employees, and facilitates that administration through the investment of retirement contributions. Both the Board Trustees and the staff at ACERA work diligently to administer benefits and maintain the health of the investment fund.



In an admittedly difficult economic climate since 2008, ACERA has stood out as an example of how a retirement fund should be administered. ACERA's net fund has a current market value in excess of \$6 billion with millions in earnings still to be recognized. Like all retirement systems, ACERA was affected by the economic crisis of 2008-2009. Subsequent hard work by all of the ACERA trustees and staff has resulted in gains in excess of \$2 billion in assets in four short years, putting ACERA in the top 4% of its peer group in the country, with returns in the top 1% in 2012.

I have had the privilege to have been one of the two trustees representing the general membership during the last four years and was Board Chairman of ACERA in 2011. Having attended Public Pension programs at U.C. Berkeley Haas School of Business and Stanford University, I carry the qualifications that are needed in order to perform the functions of an ACERA Board member. I am also a Deputy District Attorney in Alameda County with close to 25 years of experience, where my duties of representing the public at large compliment the fiduciary obligations inherent as a board trustee.

As well as the investment accomplishments listed above, I have also worked with the other trustees to preserve the Supplemental Retiree Benefits Reserve which pays for much of the health care premiums for retired employees. And I have labored together with the other trustees to preserve the current standard of retirement benefits against any negative impact from new pension legislation. Importantly, as evidenced by the endorsements below, I have worked with the other trustees and the ACERA staff in a manner that is cognizant of what is demanded of an ACERA Board member.

I wish to continue to commit myself to working on your behalf. ACERA's performance during my time on the Board has been outstanding, and in order to keep our retirement fund strong ask that you re-elect me as the general member trustee.

Alameda County Community Development Agency

Friends and fellow ACERA members, I'm seeking your support to serve on the Board of Retirement as your elected General Member representative. From 1989 to 1996 and again from 2004 to 2006, it was my privilege to serve on the Board of Retirement. While a member of the ACERA Board, it was my fiduciary duty to safeguard the assets of our pension fund by overseeing plan benefits and making reasoned financial investment decisions utilizing the expertise of ACERA staff and consultants. As a Board member, I served on the Investment, Retiree, Actuarial, Adhoc Health Care, and Compensation committees, and as Board Chair (2006).



During my tenure on the Board, I earned Certificates of Achievement in Public Plan Policy: Employee Pensions and Employee Health; completed the Pension Funds and Money Management Program at the Wharton School, University of Pennsylvania, and served on the Trustee Committee of International Foundation of Employee Benefit Plans. I also served on the Education (Chair) and Nominating Committees to the State Association of County Retirement Systems (SACRS), and regularly attended trustee roundtables and educational conferences. Given recent changes to our vested and non-vested retiree benefits, once again I'm asking for your support.

LEADERSHIP GOALS

Receiving timely information is important to all active and deferred employees, particularly changes that impact planning and enjoyment of our earned retirement. But the **Public Employees Pension Reform Act (PEPRA)** could take-away a basic retirement protection for current (vested) ACERA members. If elected, I will be an advocate for a more secure retirement, not less secure. Personnel policies should not be revised to take away benefits earned by County employees.

OTHER NEW CHALLENGES

It's easy to get fooled by retirement planning myths. Most Internet sites give advice towards purchasing a product and unwittingly well-meaning friends pass this information onto work colleagues. But apathy towards the health care **chargemaster** is the NEW problem in American medicine. As your trustee, I will work with industry leaders, ACERA staff, and my Board colleagues to make sure you have the best information available to make the prudent retirement choices.

NOTE: Time Special Report by Steven Brill – the “Bitter Pill, why Medical Bills are Killing Us” is the best information on the perils of the health care **chargemaster**.”

PEPRA UPDATE

This lawsuit is about including compensation for retirement purposes in payments for all our Paid Leave. If we win, we keep these benefits. The case is pending. Alameda County's case has been consolidated with similar lawsuits from other counties. On July 9, 2013, the Court set a briefing schedule for “first phase” issues raised in the consolidated **AB 197 lawsuits**. As of this writing, the next hearings are TBA in late October 2013.

Note: The “stay” order requires ACERA to hold off on implementing **AB 197**. But the order is subject to change by the Court.

Lastly, I appreciate your trust in me to serve as your representative again. Thank you for your support and your vote in this election.
